RECEPTIONS: OPENING — Friday, July 25th, 5-7pm, AWARDS — Sat., July 26th, 2-4pm

ELIGIBILITY: Representational and non-representational oils, watercolors, pastels, graphics, acrylics, small sculpture and collage. NO computer prints or photographs. Paintings limited to 48 inches wide and 50 inches tall. Sculpture must be free standing, limited to 50 lbs., and no larger than 36 inches in any direction. In regard to prints, we accept wood blocks, linoprints, and hand-pulled prints, i.e. monotypes, etc. Wrap Around Canvas will be accepted for oils and acrylics on canvas. Wrap Around Canvas MUST have its sides covered with a continuation of the painting itself around the edges. No staples should be visible when the painting is hung. ALL WORKS MUST BE ORIGINAL, FOR SALE, and NOT PREVI-OUSLY SHOWN AT THE KAA GALLERY. Portraits should show price of similar work. Sale price must include frame. Pictures must be framed and ready for hanging with screw eyes and wire. A limit of two entries per artist. The Kent Art Association, Inc. reserves the right to reject any and all works of art submitted to this show irrespective of jury decision..

ENTRY FORM: All entries must have entry forms properly filled out and attached to the back. (Attach to upper left corner of picture frame.) PLEASE PRINT CLEARLY. DO NOT WRITE. Do Not Cut the Form.

SALES: A commission of 30% will be deducted from the purchase price of all sales.

ENTRY FEES: MEMBERS: \$25 for 1 or 2 pieces.

NONMEMBERS: \$35 for 1 piece; \$40 for 2 pieces. Entry fees are NOT refundable. Exhibitors will be notified of jury's decision. Notification slips must be presented to obtain works at time of pickup. A SELF-ADDRESSED STAMPED ENVELOPE MUST ACCOMPANY ENTRIES ON RECEIVING DAY.

Anthony Masina was born in Yonkers, NY in 1971 and grew up in the Mid-Hudson Valley of New York State. He studied at the Pratt Institute in Brooklyn, NY with a concentration in Illustration, and then earned a BFA in Sculpture from SUNY Fredonia. In 1997 he earned an MFA in Sculpture from Louisiana State University in Baton Rouge. He has taught numerous art classes at the college level.

Anthony has worked in a variety of media. For many years, welded steel was his primary medium, though his sculptures often also contained natural and found objects. These were representational yet conceptual in nature. More recent sculptures are representational cast bronze animals. These are small scale, stylized, and highly detailed with attention to line and surface movement.

Betsy Rogers-Knox earned a Certificate in Botanical Illustration from The New York Botanical Garden, and is enchanted by the full lifecycle of the plants she portrays in watercolor and usually observes her plant subjects for a full year before beginning her compositions. Her work has been included in ASBA/HSNY 13th-16th Annual International Exhibitions, Focus on Nature Exhibition at the State Museum in Albany, NY, Loosing Paradise, Green Currency, the traveling exhibition Following in the Bartrams Footsteps, The Weird, Wild and Wonderful Exhibition at the NYBG and at the Royal Horticultural Show in London, England where she received a silver medal in 2012. Betsy teaches painting and drawing from her studio in Bethlehem, Ct and other venues in Litchfield County, Ct.

Tina Underwood - Raised in Roxbury, Connecticut, Tina Underwood received her B.A. degree in studio art from Albertus Magnus College, and studied art in Lacoste, France under the direction of Sarah Lawrence College.

Tina's paintings reflect her love of the New England countryside, where early morning or late afternoon scenes inspire her to capture the drama of light playing out before her. Strong light effects also play a role in her still life and floral compositions, which she paints from life in her north light studio, a dream studio where light and creativity flow. She has accepted many commissions, from private house and garden portraits to murals for commercial spaces. Her studio is in Bridgewater, Connecticut.
