

## JURIED HOLIDAY MARKET — MEMBERS 2012

---

DATE OF EXHIBITION: Saturdays and Sundays, November 10 through December 2 from 12-4 pm.

LOCATION: The Kent Art Association Gallery, Rte. 7, 21 South Main St, Kent, Connecticut.

WORK ELIGIBLE: For Wall Art; framed originals any medium or size (smaller and under \$100 is suggested). Printed note cards and hand pulled prints are allowed. No giclee, photographs or other prints. Portfolio originals can be exhibited in a personal or shared portfolio bin.

FOR CRAFTS: All work entered must be produced by the artisan. NO Buy and Sell.

JURYING: All work will be juried from photos or CDs. Please send a minimum of five (5) images including one (1) photo of your display and number each image according to the numbered titles on the application page. If available, please include an artist statement and biography. All applications and non-refundable application fee must be received by September 15, 2012. Artists will be notified by October 1, 2012.

Applications should be mailed to: KAA Holiday Market Chairperson, PO Box 415, Hopewell Junction, NY 12533.

Entries must include SASE, images received without SASE will not be returned. Please provide adequate postage to assure delivery to your address.

RECEIVING: Friday, November 9th, 10 am to 2 pm, or Saturday, November 10th from 10am-noon at the Gallery.

ALL WORK MUST BE HAND DELIVERED and set up by the artist.

ENTRY FEES AND REQUIREMENTS: \$25 (entry fee is waived for KAA volunteers) for up to 8 feet of wall space/2 panels with 3 feet of depth for a small table in front or up to 8 x 3 feet of floor space. If using a table it must be supplied by the artisan.

**Each participant will have to gallery sit for one 4 hour period during this Market.**

SALES: will go through a Gallery Cashier, 25% commission will be deducted from the purchase price of all sales. Connecticut Sales Tax will be collected by the Cashier and submitted by the Kent Art Association.

PROCEDURE: Each artist will be given a code by the Gallery to be used on each sales tag for the purpose of identifying each sale item; a corresponding sales list must be submitted. More information will follow with an acceptance letter.

REMOVAL OF WORK: Sunday December 2nd at 4:00 pm, Monday, December 3rd 10 am to 1 pm
