EXHIBITION DATES: April 13th - May 12th

LOCATION: KAA Gallery, Rt.7, Kent, CT.

RECEIVING DATES: Friday, April 5, from 3-5pm, and Sat. April 6 from 10am – 12pm. at the KAA Gallery, Route 7, 21 South Main Street (just south of the traffic light), Kent, Connecticut. ALL WORK MUST BE HAND DELIVERED. (Please bring a recent copy of your bio for visitor reference.)

REMOVAL OF WORK: Fri. May 17, from 3-5pm, and Sat. May 18 from 10am – 12pm. No early pickups. Strictly adhered to!

AWARDS RECEPTION: Sat. April 13th, 2-4pm, awards at 3pm.

ELIGIBILITY: Representational and non-representational oils, acrylics, watercolors, pastels, graphics, sculpture, collage, photography and digital art. Two-dimensional work limited to 48" wide x 50" tall. Sculpture must be free standing, less than 50 lbs. and no larger than 36" in any direction. We accept wood block prints, linoprints, and hand pulled prints. Wrap-around canvas acceptable, though sides must be covered with paint or continuation of image. No visible staples. Framed work should have screw eyes and wire. Sale price includes frame. Unframed work must be exhibition ready and wired to hang. ALL WORKS MUST BE ORIGINAL, FOR SALE, AND NOT PREVIOUSLY SHOWN AT KAA GALLERY. A limit of three entries per artist. The Kent Art Association, Inc. reserves the right to reject any and all works submitted to this show irrespective of jury decision.

ENTRY FORM: All entries must have entry forms properly filled out and attached to the back. (Attach to upper left corner of picture frame.) PLEASE PRINT CLEARLY. DO NOT WRITE. Do Not Cut the Form.

SALES: A commission of 30% will be deducted from the purchase price of all sales.

ENTRY FEES: MEMBERS: \$25 for up to 3 pieces. NONMEMBERS: \$35 for 1 piece; \$40 for 2 or 3 pieces. Entry fees are NOT refundable. Exhibitors will be notified of jury's

decision. Notification slips must be presented to obtain works at time of pickup. No SASE is required.

RESPONSIBILITY: The greatest possible care will be taken in handling works, but not KAA, Inc. nor any of its agents shall have any responsibility whatsoever for any loss or damage to any entry from any cause whether such entry shall be on display, in storage or in transit. Artists must carry their own insurance if deemed necessary. The Gallery requests the right to photograph work for the catalogue or press information. Submitting an entry to this exhibit implies agreement on the part of the sender with the conditions set forth above.

SPRING JURIED SHOW JUDGES

DENIS CURTISS

Denis is sculptor and a native of northwestern Connecticut. He has a diploma in Technical Drawing and a Bachelor's degree in Applied Arts, with a concentration in Art History. Through an apprenticeship with restoring fine antiques, he developed a kinship with wood and metal. Since the 1970's, he has shown sculpture in juried shows, galleries, and museums in New England, winning several awards. In 1976 he began an eighteen year career overseas teaching and studying art in Europe, Africa, Asia and the South Pacific. Since then, his work with welded steel and bronze, features oversize animals in motion. His large yard in Kent, CT, also known as Sculpture-dale, is where they cavort, weather and season. Horses rear, cats pounce and elephants trumpet. Many collections in this country, and as far away as Canada and South America, feature his work.

ANDREW RICHARDS

Andrew serves as the Chair of the Visual Arts Department for the Gunnery and has taught for over twenty five years. He earned a BFA in Studio Art from Lake Forest University and an MA in Art Education from the Rhode Island School of Design. He has exhibited in many group and solo shows in the northwest corner of Connecticut. His art addresses his interest in the environment and the way people interact with nature. Having painted landscapes and seascapes in the past, he recently is more interested in bridging painting and sculpture. His tire masks are one way of exploring making art with discarded material, and how he process looking forward rather than looking back.
