3:00.

REMOVAL OF WORK: Work may be  
removed on Sunday, March 30th from 2-4.

ELIGIBILITY: All artists may enter this show.

WORKS ELIGIBLE: Representational  
artwork (artwork depicting recognizable  
images of objects, life, landscapes, etc.)  
using the mediums of oil, acrylic, watercolor,  
pastel, graphics, small sculpture, mixed  
media, printmaking, and fiber. Photographs  
will not be included in this show.

Works which are framed must be wired  
for hanging. Sawtooth hangers will not be  
permitted. Sale price must include frame.

Works which are unframed must have  
edges finished.

All works must be original, for sale, and  
not previously shown at the KAA.

The Kent Art Association, Inc. reserves

the right to reject any and all works of art  
submitted to this show irrespective of jury  
decision.
