SELECTIONS: Saturday, May 10th from
12-1. You will only be notified if no work is
selected for the show.

**ALL WORK SUBMITTED MUST HAVE
BEEN COMPLETED WITHIN THE LAST
TWO YEARS.**

OPENING RECEPTION: Friday, May 16th
from 6-8. Awards will be announced at 7:00.

REMOVAL OF WORK: Work may be
removed on Sunday, June 8th from 12-3.

ELIGIBILITY: All artists may enter this show.

WORKS ELIGIBLE: Representational and
non-representational oils, watercolors,
acrylics, pastels, graphics, small sculpture,
mixed media, collage, photographs, wood
block prints, Lino prints, hand pulled prints
(i.e. monotypes, etc.), fiber

Photographs must be executed and altered
by the photographer only.

Pictures must be framed and ready for
hanging with screw eyes and wire.

Sale price must include frame.

All works must be original, for sale, and not
previously shown at the KAA.

The Kent Art Association, Inc. reserves
the right to reject any and all works of art
submitted to this show irrespective of jury
decision.

ENTRY FORM: **Please fill out the entry form
to the right. Please use your own index card
to label each work with your name, contact
information, name of work, medium, size,
and price. Do not cut the entry form.**

PLEASE PRINT CLEARLY.

SALES: A commission of 30% will be
deducted from the purchase price of all
sales.

ENTRY FEES: Members - \$35.00 for up
to 3 pieces; \$50.00 for 5 pieces. Non-
members - \$50.00 for up to 3 pieces.
